邱婉茜助理教授於西班牙馬德里卡洛斯三世大學 (Universidad Carlos III de Madrid) 五年取得碩士加博士學位 (Ph.D. in Business Administration and Quantitative Methods)。博士畢業後,即到英國蘇格蘭 University of Glasgow (Adam Smith Business School) 擔任助理教授三年。大學在本校計量財務金融學系就讀,2017年八月正式成為清華大學計量財務金融學系的一員。自 2017年於本校任職起,其除致力教學與行政服務外,學術研究方面亦持續積極發展而有相當優秀之表現。

邱婉茜助理教授研究興趣在於財務風險管理及公司理財。過去發表文章主要的研究主題為銀行體系風險於非財務公司的風險傳染效果;及公司債務期間結構於公司銀行借款成本的影響。研究成果發表於財務領域之國外重要學術期刊,累積逾十篇。過去幾年間已於國際學術場域榮獲若干最佳論文獎之肯定(如2015年SFM conference 最佳論文獎、2018年台灣財務協會年度國際研討會最佳論文獎等)。邱婉茜助理教授致力於國際合作研究,其研究團隊包含美國、英國、香港、台灣的學者。其研究主題更延伸到探討,無形資產價值對公司借款影響,及文字探勘在財務與會計上的研究。學術之外,邱婉茜助理教授在清華所獲得最重要的資產是學生時期清華計財系師長的教導與其啟發的人生智慧。最後,邱婉茜助理教授感謝家人長期的支持與關愛。

Wan-Chien obtained my PhD degree in Universidad Carlos III de Madrid (in Spain) in June 2014 and have been devoted to the research side of my graduate training. My dissertation examines the risk propagated in the financial sector and explores the transmission channel of the impact of financial crises from the financial sector to the real economy. After PhD, I had been employed as the Assistant Professor at University of Glasgow (in UK) from August 2014 to July 2017. My research scope at this time had expanded to the investigation of corporate debt maturity structure and bank loan contracting. My current researches also investigate the effect of trademark protection on bank loan costs; the effect of corporate social responsibility on bank lending behavior; and textual analysis in Finance and Accounting by looking at analyst reports.

During the most recent 5 years, I have 10 publications (2 publications at MOST A Tier-1 journals; 4 publications at MOST A Tier-2 journals; 4 publications at MOST B+ journals). I have been engaging in effective international research collaborations for several years, as evidence in my excellent publication outcome. I have also demonstrated an upward trajectory in terms of research quality at internationally excellent standard. My recent research teams include academics in USA, UK, Hong Kong, and Taiwan. I have won two Best Research Award in the international conferences. (1) Best Paper Award, 2018 TFA International Conference (Taipei, Taiwan); (2) Best Research Paper Award in the 23rd SFM conference.
